WI. State law requires anyone, under the age of 18 yr. old, wishing to obtain a Driver's License, must complete both Dr. Ed. Theory class and Behind the Wheel class. (All classes must be completed within 1 year of starting the program.)

**Prerequisite = Be 15 + yrs. old**

**Classes**

**Driver Ed. Theory**

The Theory class is designed to help students with the basic skills and knowledge required to operate a motor vehicle safely. It introduces and reinforces the techniques for applying the Rules of the Road to the physical, mental, and social aspects of safe driving. The class will meet daily for 2 hrs./ day (M-F) for 15 days (3 weeks). Daily attendance is mandatory. (as required by WI. State Law) If more than 2 classes are missed the student must repeat & pay \$25/class in the next session of Theory. All state manuals/books will be supplied to be **used in the classroom.** If a book/manual are taken or used for make work, and not returned a \$25 fee will be charged.

**Prerequisite = Be 15 yrs. 6 months old & successfully passed Theory Class & have acquired a Learner's Permit (Students must start their Behind the Wheel Training within 60 days of acquiring their Learner's permit.)**

**Behind The Wheel Training**

The Behind The Wheel Training class will consist of 6 hrs. 'In the Car' Driving and 6 hrs. of 'Observation'. Students will experience a variety of driving situations. It is offered: after school hours & evenings (during the school year) mornings or afternoons (in the summer) & Saturdays. A \$50 make-up fee will be charged to make up any missed BTW lessons. All fees must be paid and all requirements for course completion must be met or a **'DMV Notification of Completion'** will **not** be issued / recorded. This Notification of Completion is required to obtain a Probationary License. ( Passing the Road Test at the DMV is also required.)
